At our Oct. 14th meeting Gang Investigations Unit Sergeant Carlos Paredes will give a 30 minute presentation on what they do and how we can help rid our neighborhood of gangs. ### RESIDENTS IDENTIFY NUISANCES IN NEIGHBORHOOD

Eighteen Roosevelt neighborhood residents walked the streets with Police Captain Dewey Hosmer and two other officers, Councilmember Cindy Chavez and her Aide Jose Posadas on Saturday, September 11th. Residents pointed out the nuisance houses in our area. The problems created by the occupants include speeding cars, noise, drug traffic, brandishing of weapons, intimidating behavior, and loitering. Although our neighborhood residents have made the police aware of most of these problems, our members stressed how the residents of these homes are a continual problem and are negatively impacting our lives. We hope to see the resolution of these problems in the months ahead. Thanks to all who participated!

### NEIGHBORHOOD TASK FORCE NEEDS A REPRESENTATIVE

As a Roosevelt Park resident, you are eligible to represent us on a task force organized by Council Representative Cindy Chavez. She is starting this task force in October to create a neighborhood investment district. The purpose of the force is two fold: 1)To determine if the area is eligible for redevelopment funds, 2)What to do to improve the area if it does become eligible

### REPORT FROM THE BLIGHT TO BEAUTIFICATION COMMITTEE

This committee currently consists of: Terilyne Ramadan, Sonia Alvarez, Julio Lucas, Rebecca Hernandez-Ross and AliceRose Houtz. When was the last time you drove around the Northside neighborhood? Perhaps you noticed that the homes are no different from ours. What's different is that the majority of them are well maintained. It only takes a few blighted homes on a block to give the impression this is a run-down area, an area that scares other San Jose residents from visiting our local businesses and purchasing homes in our neighborhood. What does it mean to have a well maintained home? Maintaining a home means to pick up the trash, provide simple landscaping, paint the home, repair broken windows, and rake leaves. Neighbors have used the city roofing program to install new roofs at a fraction of the original cost. What does the house you live in look like? Do you need neighbors to assist you in cleaning up your property? Are you interested in the various programs the city offers? If you answered yes to these questions, please come to the next meeting. Our committee is aimed to inform people about the programs that the city provides to assist us in making repairs, cleaning up and helping to landscape.

Volunteer interim Board Members are: Sonia Alvarez, Allen Conrad, Ted Cunningham, Norma Freitas, Briton Hefty, Michelle Kalish, and Terilyne Ramadan.

The walk-through planned for the following Saturday with Council Member Cindy Chavez was discussed, along with problem houses on San Antonio and South 20th, including whether or not they were "gang houses." Problems on Bulldog Lane were mentioned.

Minutes for the August 12th meeting, in the form of a Newsletter summary, were approved.

Rob Boyles gave a presentation of graffiti, the need for neighbors to clean up immediately, the increased penalties for offenders, and distributed over 20 clean-up kits.

The remaining time was spent with the following committee meetings: litter abatement, tree planting, and blight.

## LITTER COMMITTEE CLEAN-UP

The Litter Committee held their first neighborhood pick up on Sunday, Sept. 19th. The volunteers picked up 18 bags of trash between 19th and 21st streets, and between San Fernando and Santa Clara, with heavy concentration on Santa Clara St.

The next pick up is scheduled for the weekend of Oct. 2nd.
